I agree to inspect the facilities and equipment to be used and if I believe anything to be unsafe I will immediately advise the organisers of such conditions and refuse to participate.

I understand and agree that skating and skateboarding activities are dangerous and that I will be exposed to various risks, not only from my own actions, but the actions of others, the conditions of the premises or any equipment used, as well as from circumstances that may be not known to me or not reasonably foreseeable at this time.

The risks include, but are not limited to, bruises, broken bones, dislocations and muscle pulls, permanent paralysis or death. The participants may suffer injury to their person, or damage to their property while merely observing or being in proximity to event activities.

The participant agrees to follow the rules of the event, and that failure to do so may result in exclusion from the event, without refund.

The participant voluntarily assumes all risk of loss, damage or injury while on the premises.

The participant agrees to indemnify 'Christian Surfers', and 'Holy Trinity Church' against and save it harmless from any and all damages, actions, claims, judgements, cost of litigation and legal fees which may result from the participants use of, or presence at the event, including damage to the equipment of Christian Surfers.

In the event of illness or accident, I give my permission for medical treatment to be administered where considered necessary by a nominated first-aider, or by suitably qualified medical practitioners. If the above noted emergency contact person cannot be contacted and I should require emergency hospital treatment, I authorise an adult leader to sign any written form of consent required by the hospital.

I declare that I have no physical or medical conditions that would be affected by my participation in the event.
